It is time once again to send out the applications for the annual Rosemary Beach Holiday Market that is scheduled for Nov. 27, from 9 a.m. - 5 p.m. on the eastern and western lawns of the property. Once again, only 50 vendors will be able to set-up for this year's market, due to the fact of the playhouses and dog houses that are being built and auctioned off that day for charity, will be erected on the east lawn.

The entire weekend will be filled with events that include the lighting of the town and the turning on of the town Christmas tree on Nov. 26, live entertainment throughout the ceremony and the following day during the market, the arrival of Santa, Breakfast with Santa the morning of the market, strolling carolers, a holiday movie, and much more.

Various shops and Rosemary Beach merchants will also be having events and activities throughout the weekend, getting the holiday season kicked into high gear. Last year, more than 5,000 people walked the lawns during the tree lighting and then the next day during the Holiday Market and the Breakfast with Santa.

Hilltop Productions is currently seeking artists/vendors to take part in this year's market.

Those vendors who specialize in holiday decorations, gifts and Christmas specialty items, are especially encouraged to register. For those who do not specialize in holiday items, they are encouraged to make their booth space as festive as possible.

Various organizations will take part in the market with Christmas tree and wreath sales, ornament decorating, Christmas baskets, and other holiday items. Spaces are limited and in the past five years, vendor spaces always sell-out prior to Oct. 1. - * All artists/vendors are responsible for their own sales tax (7% in Walton County)
- * All artists/vendors must be able to show in the designated 12 x 14 booth space, or must pay for another 12 x 14 space
- * No set-up before 7 a.m. and all artists/vendors must vacate property before 7 p.m.

SPACES ARE AVAILABLE AT A FIRST COME, FIRST SERVE BASIS AND THE 2010 WEST INDIES MARKET ANNUAL SPACES DO NOT APPLY TO THE HOLIDAY MARKET. THERE ARE NO RAIN DELAYS OR REFUNDS

Space is limited due to the amount of activity on of all the lawns, in the town square, the town hall and merchant storefronts. There can be no more than 50 vendors, 10 less than the spring and summer monthly West Indies Markets.
