Dear vendors:

Thank you once again for an incredible 2010 Seabreeze Jazz festival. Plans, acts, accommodations and other aspects for the 2011 event are already being locked down and tickets went on sale May 1st .

The 2011 WSBZ Seabreeze Jazz Festival can accept a total of 50 artist/crafter/commercial vendors and five food vendors to take part in the event. In the past we have had vendors from all across the South, throughout the North, from the west coast, Mexico, Australia, England, France, Canada, South America, Africa and Spain.

With the national and international attention the festival has received over the past few years, the Seabreeze Jazz Festival was this year named the largest attended smooth jazz festival in the nation. WOW! We finally did it!

More than 17,000 tickets were sold for the 2010 jazz festival, with sell-out crowds for the smooth jazz cruise, the VIP area, corporate tables at \$5,000 each and Friday and Saturday's concerts. WSBZ 106.3, the city of Panama City Beach, Pier Park and the park management group, are already gearing up for the 2011 festival.

This past year's festival, more than 30 artists/crafters and commercial vendors, were on a waiting list for a spot. Since the announcement, more than 200 emails and calls pertaining to the 2011 Seabreeze Jazz Festival, have flooded the Hilltop Productions office and website. Many have called in, or emailed our office, that showed this past year, as well as, new vendors, wanting a space for the 2011 WSBZ Seabreeze Jazz Festival. The excitement is building, thus Hilltop Productions is responding earlier once again this year by getting registration/applications out to begin filling the spaces for the 2011 event.

Enclosed is an application for artist/crafter vendors, commercial vendors and food vendors, along with a letter of introduction. This year, there will be **six platinum** vendor spaces located at the front of the commercial/artists/crafter market, directly behind the sidewalk.

Spaces for the 2010 Seabreeze Jazz Festival sold out the first week of February.

Please read the guidelines and policies, and if you would like to participate in the 2011 WSBZ Seabreeze Jazz Festival, please fill out the necessary paperwork, and submit with proper fee.

Partial payment will not be accepted - NO vendor space is reserved without full payment.

- * Power will be supplied by Hilltop Productions by means of generators. There will be no increase in cost for power to vendors, but vendors must supply ample extension chords.
- * All vendors must set-up during designated times and be able to exhibit in their paid spaces.
- * A three-day set-up (April 15-17) is required.
- * State of Florida and the City of Panama City Beach sales tax applications and redemption forms will be included with your check-in packet.
- * All vendors must park in designated areas.
- * Only two badges will be issued per booth space. Additional badges (up to 2) can be bought for \$50 each for the weekend/\$100 beginning April 1, 2011.
- * Load in, tent and merchandise set-up has been set for Thursday, April 14, from 8 a.m. - 4 p.m., ONLY. Merchandise can be brought in ONLY by hand cart or dolly on Friday morning, or the morning of the Saturday and Sunday show, but absolutely no vehicles will be allowed into the event venue. This is due to the fact that the barricades and fencing will be secured by 5 p.m. on Thursday, April 14, in preparations for the Friday evening opening concert.
