## 2011 WEST INDIES MARKET

Rosemary Beach, FL

It is time once again to plan for the Rosemary Beach West Indies Markets. The season will run from May-July with the following guidelines for annual and per show vendors.

- 1) All items must be handmade and crafted by the vendor that is exhibiting. Once again, ABSOLUTELY NO RESALE OR WHOLESALE!
- 2) All vendors must have a 10 x 10 white tent. Items can be placed outside the tented area, but must be able to be contained within a 12 x 14 area.
- 3) Markets will once again run from 11 a.m. - 6 p.m. on Saturday and 10 a.m. - 5 p.m. on Sunday with set-up for vendors no earlier than 8 a.m.
- 5) Once again, only 60 vendors per market weekend.
- 6) A two-day market set-up is required.
- 7) No pets are allowed in exhibiting area.
- 8) Fans, cash registers, machines, etc., are allowed, but power must be supplied by a quiet-running generator that can be out of view and foot traffic area. **POWER IS NOT SUPPLIED.**
- 9) Parking spaces once again around the North Barrett Square, is for customer and merchant parking ONLY. Vendors can unload their merchandise, but then must find parking either in the maintenance, tennis, or Rosemary Beach employee parking areas.
- 10) NO OVERNIGHT PARKING or leaving of trailers, wagons or trucks on Rosemary Beach property. All vehicles and transport vehicles, must be vacated at the end of each market day.
- 11) Security will be provided once again on Saturday evenings of the market.
- 12) All vendors are responsible for their own sales tax. It is 7% in Walton County.
- 13) THERE ARE NO RAIN DELAYS OR REFUNDS FOR ANNUAL OR PER-SHOW VENDORS.
- 14) No boxes, trash, containers, etc., can be left at venue site. If you bring it, you take it!
- 15) all new applicants must submit photos of work being sold
